

RESIDENTIAL BUILDING PERMIT APPLICATION



Residential Building Permit applicable to detached One- and Two-Family Dwellings and Townhouses not more than 3 Stories above grade and associated accessory structures. Permit must be issued before construction begins. Application for this permit may be made to the Building Official or designate.

This application is for a Residential Building Permit for the purpose given and described in this form. This application is subject to all local and state laws and ordinances. The signer agrees to all laws and ordinances deemed a condition of applying for this permit.

VDOT property entrance documentation is required with all permit applications.

Applications must be accompanied by ONE set of construction plans.
