Please accept our sincere thanks for all of your efforts to serve the citizens and businesses of our communities. We recognize that many organizations provide services to our citizens and that many localities fund the same local organizations. Over the years, we have found that the Joint Budget process to receive and review funding requests is efficient for both the local governments involved and the external agencies requesting funding.

Budget instructions have been specifically tailored for each agency, so please carefully review all instructions prior to completing your FY 2027 requests. The instructions offer a *step-by-step* guide for the development of requests and the completion of all required forms. The budget forms are intended to provide information that will assist us in the review process.

Budget submissions should include the following:

- NRVJ Budget Form 1A (All Agencies)
- NRVJ Budget Form 1B Revenue and Expense (All Agencies)
- NRVJ Budget Form 2A (Human Services Agencies only)
- NRVJ Budget Form 2B (Human Services Agencies only)
- Any supporting documentation that you believe justifies the request
- Last year's audit or a statement explaining why the audit is not included

Please note that as part of the review process, it is possible the group or an individual government may request additional information.

Completed budget submissions should be sent by email (no hard copies please) to <u>EACH</u> contact person listed in the table that follows by <u>no later than December 31, 2025</u>. If you are <u>not</u> requesting funds from a particular locality, please confirm that by email as well.
